

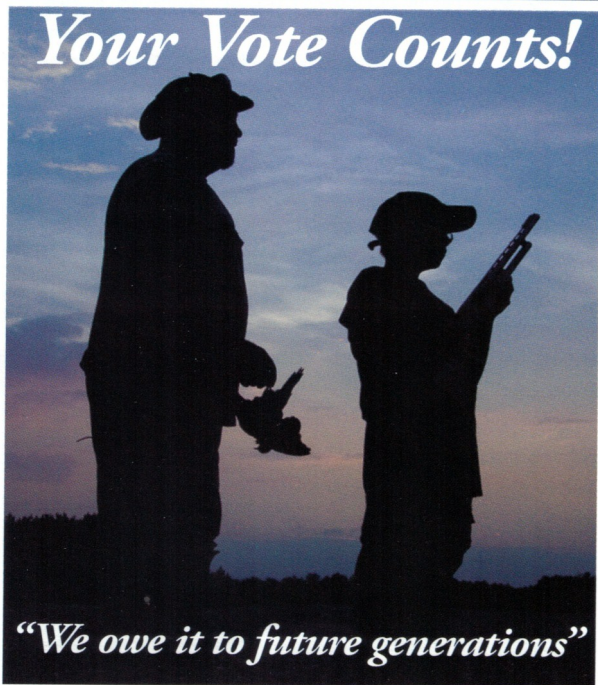
## Get Out and VOTE!

**Voter apathy** is a term used in politics to describe a perceived 'lack of caring' in voters during an election. This attitude occurs most especially when one party has a large majority or whenever voters have little influence.

Many New Yorkers feel they can't overcome the sheer number of New York City voters and have little effect on statewide elections..... **WRONG!**

### Here are the facts:

- 11 Million Eligible Voters in New York State
- 4.2 Million Voters in New York City
- 6.8 Million Voters outside of New York City
- 60% of Eligible Voters (over 6 Million) are Gun Owners



On Election Day, get out and cast your ballot for Pro Constitution Candidates! Inform yourself on which candidate has signed a pledge to repeal the SAFE Act by using the SCOPE Voter App and SCOPE's Candidate Report Card.

## The Four Basic Rules of Safe Gun Handling

1. **Treat every firearm as if it's loaded** even if you are absolutely certain a gun is unloaded.
2. **Never point a gun at anything you are not willing to destroy** always keep your gun pointed in a direction that would safely stop the bullet should it discharge
3. **Always be sure of your target and what is beyond it** you are responsible for the entire path of every bullet fired from your gun. If you hit your intended target, the bullet may still continue through
4. **Keep your finger off the trigger until you are on target and ready to fire** your trigger finger should always be outside the trigger guard and resting straight and flat alongside the body of your gun

### What You Need to Know

#### **S**ale or Disposal of Firearms

Private Sale or Disposal of Firearms, Rifles and Shotguns Require a National Instant Criminal Background Check – NICS – Through a Federally Licensed Firearms Dealer – FFL

Some exemptions for immediate family members. Immediate Family members is defined as Spouses, Domestic Partner, Children, and Step Children

**Knowingly violating this provision is a class A Misdemeanor.**

#### Muzzle-Loading Rifles and Shotguns

Generally exempt from NICS check requirement. **Possession by a person who has been convicted of a felony or serious offense is a Misdemeanor.**

#### Firearms

Possession Restricted to licensed individuals and law enforcement personnel.

Must be registered by serial number and caliber. Survivors in possession are required to surrender firearms to law enforcement or participating licensed firearm dealer pending final resolution of ownership. May be sold to benefit rightful heir or estate. **Criminal possession of a Firearm is a felony.**

#### Antique Firearm

Is not exempt from Firearms Restrictions if Loaded. “Loaded Firearm”
